CRUISE WITH CONFIDENCE: On voyages through April 2022, flexibility to cancel up to 30 days prior to sailing without incurring any penalties, when selecting a Future Cruise Credit. On our 2021 voyages, we have relaxed our cancellation penalty rules in case of opting for a cash refund as following: Cancellations up until 61 days prior to cruise: standard admin fee applies; Cancellations 60-31 days prior to cruise: 50% of the cruise fare per person applies; Cancellations 30 days prior to cruise: 100% of the cruise fare per person applies.
